This class is a qualifier for the NPS/ ANTHONY EVANS ARENA EVENTING CHALLENGE FINAL. The final to be held at Vale View Equestrian, on the 14<sup>th</sup> of September 2025. The final is open to mares, geldings and stallions four year old and over, maximum height of 158cm and in possession of an equine passport but no specific registration or breed society criteria.

Qualification will be gained by achieving a top 10 placing, with a qualification card to be handed out. Qualification will be confirmed by the NPS Office. Any qualification gained in the 60/70cm or 80/90cm will jump the higher limit in the final.

No membership needed to qualify, but owner must become NPS member compete in the final (Life, Qualifying or Performance member).
